LIZA D. CORRO, hereinafter referred to as "UP CEBU"

JOSMEF ENTERPRISES a domestic corporation duly organized and existing under the laws of the Republic of the Philippines with office address at Javellana Bldg., E. Lopez St. Jaro Iloilo City, Philippines represented herein by its Proprietor, MARLYN A. PUGOY hereinafter called "the Supplier".

WHEREAS, UP Cebu invited bids for certain goods and ancillary services, viz., "Supply and Delivery of Medical and Disaster Response Equipment" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Sixty Five Thousand Pesos (Php 65,000.00) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (eg. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the UP Cebu's Notice of Award.
- 3. In consideration of the payments to be made by UP Cebu to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the UP Cebu to provide the goods and services and to remedy defects therein if any in conformity in all respects with the provisions of the Contract.

4. UP Cebu hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
