

## REQUEST FOR EXPRESSION OF INTEREST FOR

### *Procurement of Detailed Architectural and Engineering Design for the UP Cebu Dormitory*

1. **The University of the Philippines Cebu**, through the **GAA** intends to apply the sum of **Three Million Five Hundred Thousand Pesos** being the Approved Budget for the Contract (ABC) to payments under the contract for *the Procurement of Detailed Architectural and Engineering Design for the UP Cebu Dormitory*. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.

2. The *University of the Philippines Cebu* now calls for the submission of eligibility documents for *Architectural and Engineering Services*. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **January 15, 2024 10:00 AM** at BAC Office, Ground Flr., New Science Bldg.. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.

3. Interested bidders may obtain further information from *The University of the Philippines* and inspect the Bidding Documents at the address given below during *office hours, Monday - Friday, 8:00AM-5:00 PM.*

4. A complete set of Bidding Documents may be acquired by interested Bidders on **January 8, 2024** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (₱5,000.00).*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of **Three (3)** prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

6. Bidding will be conducted through open competitive bidding procedures using nondiscretionary “pass/fail” criterion as specified in the IRR of RA 9184. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

7. The contract shall be completed within *160 calendar days*.

8. The Procuring Entity will hold a pre-bid conference for this Project on **January 24, 2024 10AM at UP Cebu BAC Office Ground Floor New Science Bldg** and through video-conferencing/web casting via Meeting ID: 963 3834 4835 PW: UPCBACPreB

10. The deadline for submission of bids is **February 7, 2024 10AM**

The *University of the Philippines Cebu* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
